# 1 Task

On behalf of the Gabriel A/S company, DK – 9000 Aalborg, the sound absorption of the wool felt fabric type Europost 2 had to be measured according to EN ISO 354 [1] in the reverberation room. The fabric was tested in a flat and a folded arrangement with a distance to the reflective wall of 100 mm.

# 2 Basis

This test report is based on the following documents:

- [1] EN ISO 354: Acoustics Measurement of the sound absorption in a reverberation room. 2003
- [2] EN ISO 11654: Acoustics Sound absorbers for use in buildings Rating of sound absorption. 1997
- [3] ISO 9613-1: Acoustics; Attenuation of sound during propagation outdoors; part 1: calculation of the absorption of sound by the atmosphere. 1993
- [4] ASTM C 423-09a: Standard Test Method for Sound Absorption and Sound Absorption Coefficients by the Reverberation Room Method. Revision: 09a
- [5] EN 29053: Acoustics Materials for acoustical applications Determination of airflow resistance. March 1993

# 3 Test objects and measurement conditions

## 3.1 Measurement conditions

The installation of the test objects was carried out by employees of the test laboratory in the reverberation room of Müller-BBM. The test object was installed in a flat (G-100) and a folded arrangement.

The mounting details are as follows:

- clear distance to the wall 100 mm, construction without enclosing frame
- fixed directly underneath the ceiling, suspended on a metal rail, height 50 mm

The mounting details for the two tested arrangements are as follows:

- a) flat arrangement G-100
  - mounting type G-100 according to EN ISO 354 [1] section 6.2.1 and appendix B.5 of EN ISO 354 [1]
  - arranged in 3 curtains (2 curtains with width x height = 1.44 m x 3.00 m, 1 curtain with width x height = 1.24 m x 3.00 m), overlapping approx.
    20 mm
  - total dimensions of the test surface (starting at the lower border of the metal rail): width x height = 4.08 m x 2.95 m
  - total test surface  $S = 12.04 \text{ m}^2$
- b) folded arrangement
  - 100 % folded as shown in figures C.1 C.2 in Appendix C
  - arranged in 5 curtains (width x height = 1.44 m x 3.00 m), overlapping approx. 20 mm
  - total dimensions of the test surface (starting at the lower border of the metal rail): width x height = 3.51 m x 2.95 m
  - total test surface S = 10.35 m<sup>2</sup>

The tested arrangements are indicated in table 1.

## 3.2 Test objects

The tested material is described by the manufacturer as follows:

- manufacturer Gabriel A/S
- wool felt fabric, type Europost 2, color 60999 black
- single layer, material 100 % pure new wool

The testing laboratory has measured as follows:

- are	a specific mass:	<i>m"</i> = 568 g/m²
- thic	kness:	<i>t</i> = 2.1 mm
- air	flow resistance acc. to EN 29053 [5]:	<i>R</i> <sub>S</sub> = 428 Pa s/m

# 4 Execution of the measurements

The measurements were executed and evaluated according to EN ISO 354 [1].

The test procedure, the test stand and the test equipment used for the measurements are described in Appendix D.

# 5 Evaluation

The sound absorption coefficient  $\alpha_s$  was determined in one third-octave bands between 100 Hz and 5000 Hz according to EN ISO 354 [1].

In addition to the sound absorption coefficient  $\alpha_s$  the following characteristic values were determined according to EN ISO 11654 [2].

- Practical sound absorption coefficient  $\alpha_p$  in octave bands
- Weighted sound absorption coefficient  $\alpha_w$  as single value The weighted sound absorption coefficient  $\alpha_w$  is determined from the practical sound absorption coefficients  $\alpha_p$  in the octave bands of 250 Hz to 4000 Hz.

According to ASTM C 423-09a [4] the following characteristic values were determined:

- noise reduction coefficient NRC as single value: Arithmetical mean value of the sound absorption coefficients in the four onethird-octave-bands 250 Hz, 500 Hz, 1000 Hz and 2000 Hz; mean value rounded to 0.05
- sound absorption average SAA as single value: Arithmetical mean value of the sound absorption coefficients in the twelve onethird-octave-bands between 250 Hz and 2500 Hz; mean value rounded to 0.01

## 6 Measurement results

The sound absorption coefficients  $\alpha_s$  in one third-octave bands, the practical sound absorption coefficients  $\alpha_p$  in octave bands and the single values  $\alpha_w$ , NRC and SAA are indicated in the test certificates in Appendix A.

## 7 Remarks

The determined test results only refer to the test specimens and prevailing conditions on the day of measurements.








Figure C1. Folded arrangement: front view.




Figure C2. Folded arrangement: details section B-B (left) and A-A (right).

# Description of the test procedure for the determination of the sound absorption in a reverberation room

# 1 Measurand

The sound absorption coefficient  $\alpha$  of the test object was determined. For this purpose the mean value of the reverberation time in the reverberation room with and without the test object was measured. The sound absorption coefficient was calculated using the following equation:

$$\alpha_{\rm S} = \frac{A_{\rm T}}{\rm S}$$
$$A_{\rm T} = 55,3 \ V \left(\frac{1}{c_2 T_2} - \frac{1}{c_1 T_1}\right) - 4 \ V \ (m_2 - m_1)$$

With:

 $\alpha_{\text{S}}$  sound absorption coefficient;

- $A_{T}$  equivalent sound absorption area of the test object in m<sup>2</sup>;
- S area covered by the test object in m<sup>2</sup>;
- V volume of the reverberation room in m<sup>3</sup>;
- *c*<sub>1</sub> propagation speed of sound in air in the reverberation room without test object in m/s;
- c<sub>2</sub> propagation speed of sound in air in the reverberation room with test object in m/s;
- $T_1$  reverberation time in the reverberation room without test object in s;
- $T_2$  reverberation time in the reverberation room with test object in s;
- $m_1$  power attenuation coefficient in the reverberation room without test object in m<sup>-1</sup>;
- $m_2$  power attenuation coefficient in the reverberation room with test object in m<sup>-1</sup>.

The different dissipation during the sound propagation in the air was taken into account according to paragraph 8.1.2 of EN ISO 354 [1]. The dissipation was calculated according to ISO 9613-1 [3]. The climatic conditions during the measurements are indicated in the test certificates.

Information on the repeatability and reproducibility of the test procedure are given in EN ISO 354 [1].

# 2 Test procedure


## 2.1 Description of the reverberation room

The reverberation room complies with the requirements according to EN ISO 354 [1]. The reverberation room has a volume of  $V = 199.6 \text{ m}^3$  and a surface of  $S = 216 \text{ m}^2$ . Six omni-directional microphones and four loudspeakers were installed in the reverberation room.

In order to improve the diffusivity, six composite sheet metal boards (1.2 m x 2.4 m) and six composite sheet metal boards (1.2 m x 1.2 m) were suspended curved and irregularly.

## 2.2 Measurement of reverberation time

The determination of the impulse responses were carried out according to the indirect method. In all tests, a sinusoidal sweep with pink noise spectrum was used as test signal. In the reverberation room with and without test objects each 24 independent combinations of loudspeakers and microphones were measured. The reverberation time was evaluated according to EN ISO 354 [1], using a linear regression for the calculation of the reverberation time  $T_{20}$  from the level of the a backward integrated impulse response.

The determined reverberation times in the reverberation room with and without test object are indicated in Table D1.
